NYSDOT has requested changes to the *FFYs 2023-2027 TIP*. The TIP Development Committee (TDC) reviewed the proposed changes on January 25, 2024, and recommends favorable action for Proposed Planning Committee Resolutions 24-01 through 24-02.

Change in Project Schedule

1. Planning Committee Resolution 24-01 (Modifying the *FFYs 2023-2027 TIP* by modifying phases of the Rt 31, Rt 31A, and Redman Rd Intersection project) (TIP # H23-75-MN2, PIN 40C103) – NYSDOT

Defer a FFY 24 Detailed Design phase of \$78,000 (\$70,000 Federal) to FFY 25. *Delete* a FFY 24 ROW Acquisition phase of \$14,000 (\$13,000 Federal).

The source of Federal funds programmed is the Highway Safety Improvement Program. The Detailed Design phase is being deferred to the next FFY to better align with the anticipated delivery date for this phase. The ROW Acquisition phase is being deleted because appraisals conducted under this phase are valid for only a single year and would likely have to be redone if the project does not advance in a timely manner. There is also a small risk of "Advanced Acquisition", illegal under federal law, if the project is not progressed in a timely manner. NYSDOT anticipates pursuing ROW Acquisition funds in the future.

2. Planning Committee Resolution 24-02 (Modifying the FFYs 2023-2027 TIP by deferring phases of the Rt 19 over Black Creek Bridge Replacement (BIN 1015260) project)

(TIP # B23-44-GN2, PIN 401920) – <u>NYSDOT</u>

Defer a FFY 24 Detailed Design phase of \$41,000 (\$29,000 Federal) to FFY 25. Defer a FFY 24 ROW Acquisition phase of \$14,600 (\$10,200 Federal) to FFY 25.

The source of Federal funds programmed is the Surface Transportation Block Grant (STBG) Flex program. These phases are being deferred to account for a delay in wetland delineation, which will make achieving Design Approval in FFY 2024 impossible. This delay is not expected to impact project delivery (PS&E).

- 3. The source of Federal funds is the Highway Safety Improvement Program;
- 4. The proposed change is described on the attached Project Detail Sheet;
- 5. The timing of this project is such that a modification of the *2023-2027 TIP* is now called for;
- 6. The GTC *TIP Procedures Manual* authorizes the Planning Committee to make TIP modifications of this nature;
- 7. The actions authorized under GTC Resolution No. 78-4 are consistent with an "Administrative Modification" as defined in 23 CFR 450.104; and
- 8. The Planning Committee is satisfied that this modification to the *2023-2027 TIP* is within the limits of reasonably expected funding resources and is consistent with the Long Range Transportation Plan.
